This is a great way to reduce your contribution to the climate change problem. There is a cost for the service, but many can reduce the expense by lowering their trash capacity. And remember - all food service ware must be recyclable or compostable. Plastic straws and stir sticks are banned, no Styrofoam is allowed, and plastic bags are no more!

RECYCLE RIGHT!

The global recycling market is in turmoil. Among the recent changes are much stricter standards for what recyclers will accept. Here's how you can help:

CLEAN and **DRY**. Before placing recyclables in your bin, be sure to empty containers of all liquids first then give them some time to dry before tossing them in your recycling bin. Remove as much food as possible from containers by scraping and giving them a light rinse.



SORT THOROUGHLY. Make sure all of your paper, plastic and other recyclables are separate from each other and loose and lightweight items are contained.

Be a SAVVY SHOPPER! Buy local, buy in bulk and when possible, buy less! Avoid plastic and excessive packaging wherever you can.

TAKE IT BACK! Paint, used motor oil, batteries, fluorescent light bulbs, leftover medicines and used sharps can be taken back to the store. None of these products should ever go in your trash or recycling bins. For more info go to www.santacruzcountyrecycles.org.



KEEP IT GREEN!

The leaves and lawn clippings you put into your green bin are turned into mulch and compost and returned to the earth. But there's one problem: Plastic! Please don't bag your green waste; plastic should never go in the yard waste cart.
