BEGINNING at a 1/2" pipe at the Southerly corner of that 10.607 acre parcel of land, as shown upon the Record of Survey Map, filed for record February 1, 1965, in Map Book 43, page 7, Santa Cruz County Records; thence from said point of beginning along the Southwesterly and Northwesterly line of said 10.607 acre parcel North 26° 43' West 411.53 feet to a point; thence North 26° 57' West 180.90 feet to a point; thence North 21° 49' East 805.44 feet to a 1/2" pipe at the most Northerly corner of said 10.607 acre parcel on the Southwesterly line of the lands conveyed to W.
